São Paulo, 17 de junho de 2020 – A BRASKEM S.A. (B3: BRKM3, BRKM5 e BRKM6; NYSE: BAK; LATIBEX: XBRK) ("Companhia"), em atendimento ao disposto no artigo 12 da Instrução CVM nº 358/02, vem comunicar aos seus acionistas e ao mercado que recebeu correspondência do Norges Bank Investment Management, pessoa jurídica de direito privado, com sede na Cidade de Oslo, Noruega, localizada à Bankplassen 2, P.O. Box 1179 Sentrum, 0107 Oslo, Norway, inscrita no CNPJ/ME sob o número 05.839.607/0001-83 ("Norges Bank"), informando que alienou, na data de 15 de junho de 2020, ações preferenciais classe A de emissão da Companhia, reduzindo sua participação para 16.928.521 ações preferenciais classe A representativas de 4,906% do total de ações preferenciais classe A emitidas pela Companhia.

O Norges Bank informou, ainda, que a redução da participação societária teve por objetivo a mera realização de operações financeiras, não objetivando alteração do controle acionário ou da estrutura administrativa da Companhia.

(II) The purpose of the acquisition and the interest is purely investment.

(III) On 15/06/2020 Norges Bank's holding in Braskem SA (ISIN: BRBRKMACNPA4) fell below the 5% threshold and amounted to 16,928,521 shares or 4.906% based upon 345,049,672 total Preference A shares outstanding. The threshold crossing does not alter the control or the administrative structure of Braskem SA. Norges Bank does not have any other securities or derivatives referenced to shares held directly by Norges Bank.

(IV) Before falling below the 5% threshold, Norges Bank held 17,266,592 Preference A shares in Braskem SA, equal to 5.011% of the total units.

(V) No shareholders' agreement or contract regulating the right to vote or purchase and sale securities issued by the company exists.
