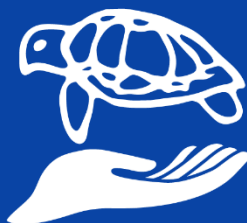

I'M GREEN Recycled

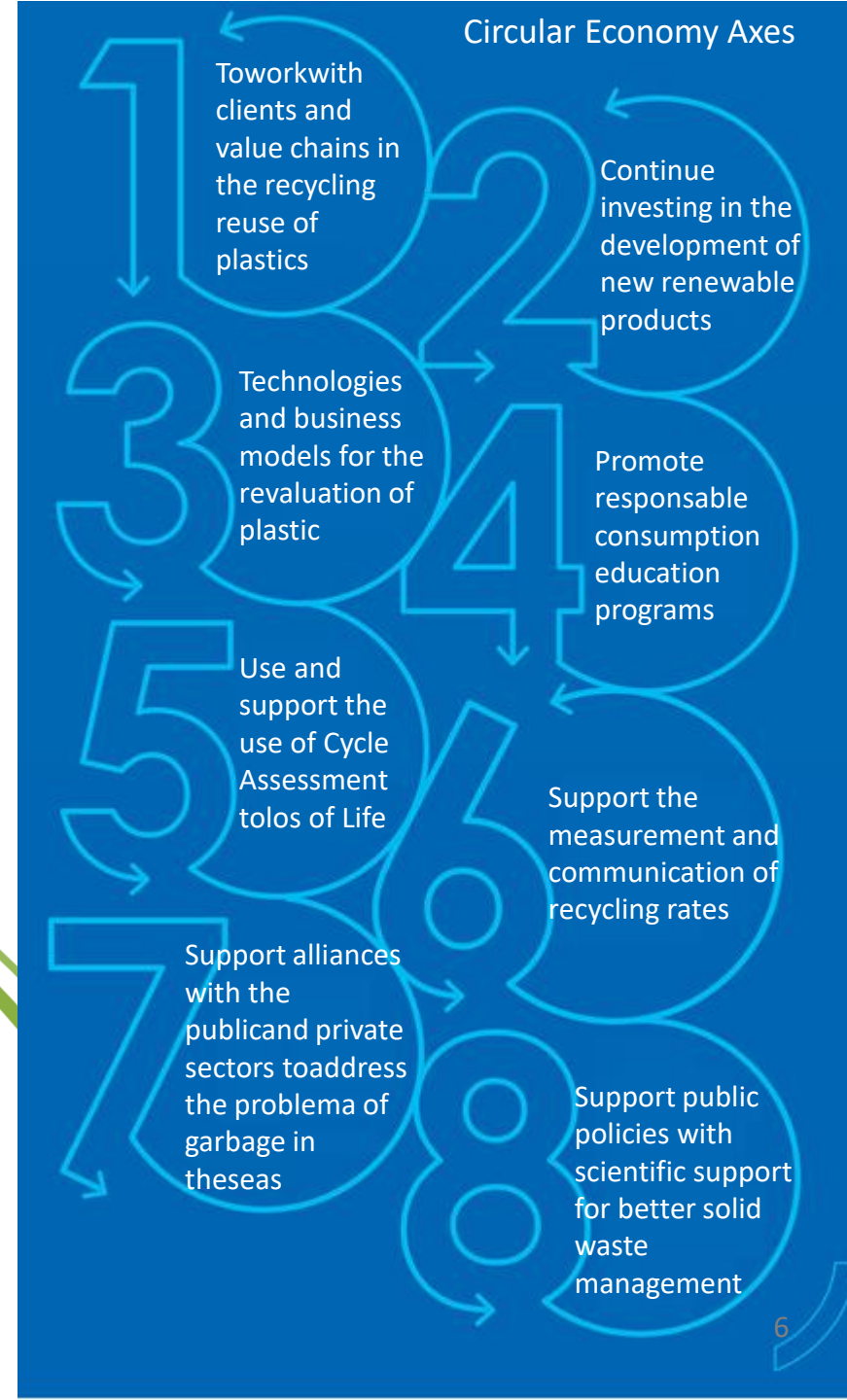
In November 2019 we release our I'm Green® portfolio, which are products made from recovered plastic.

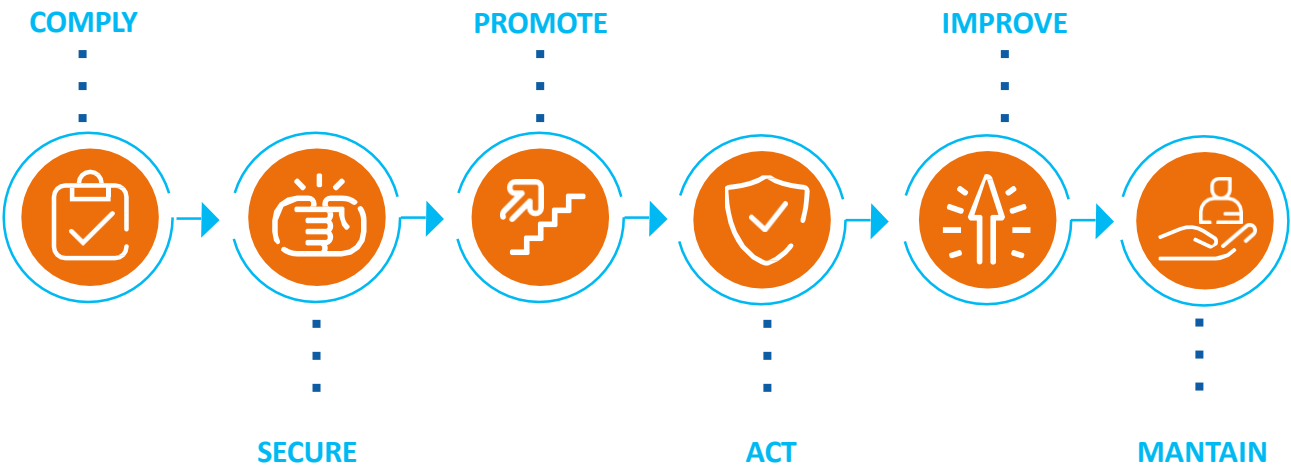

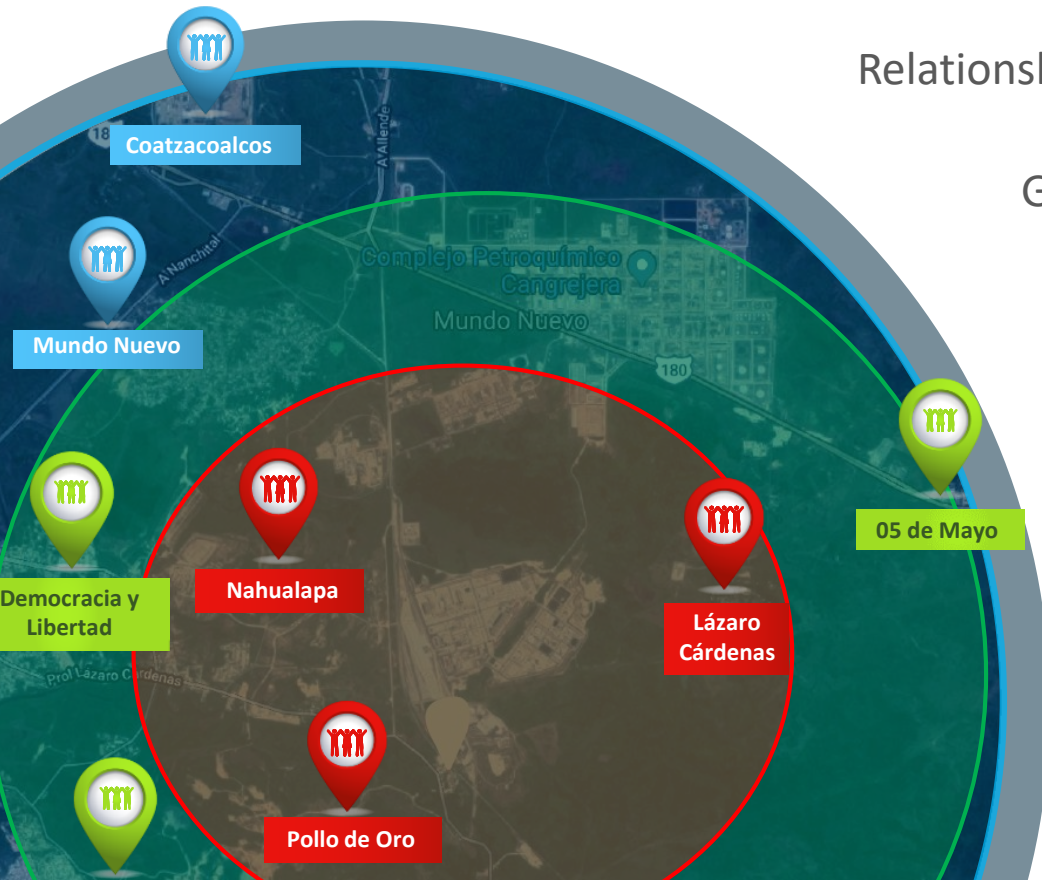

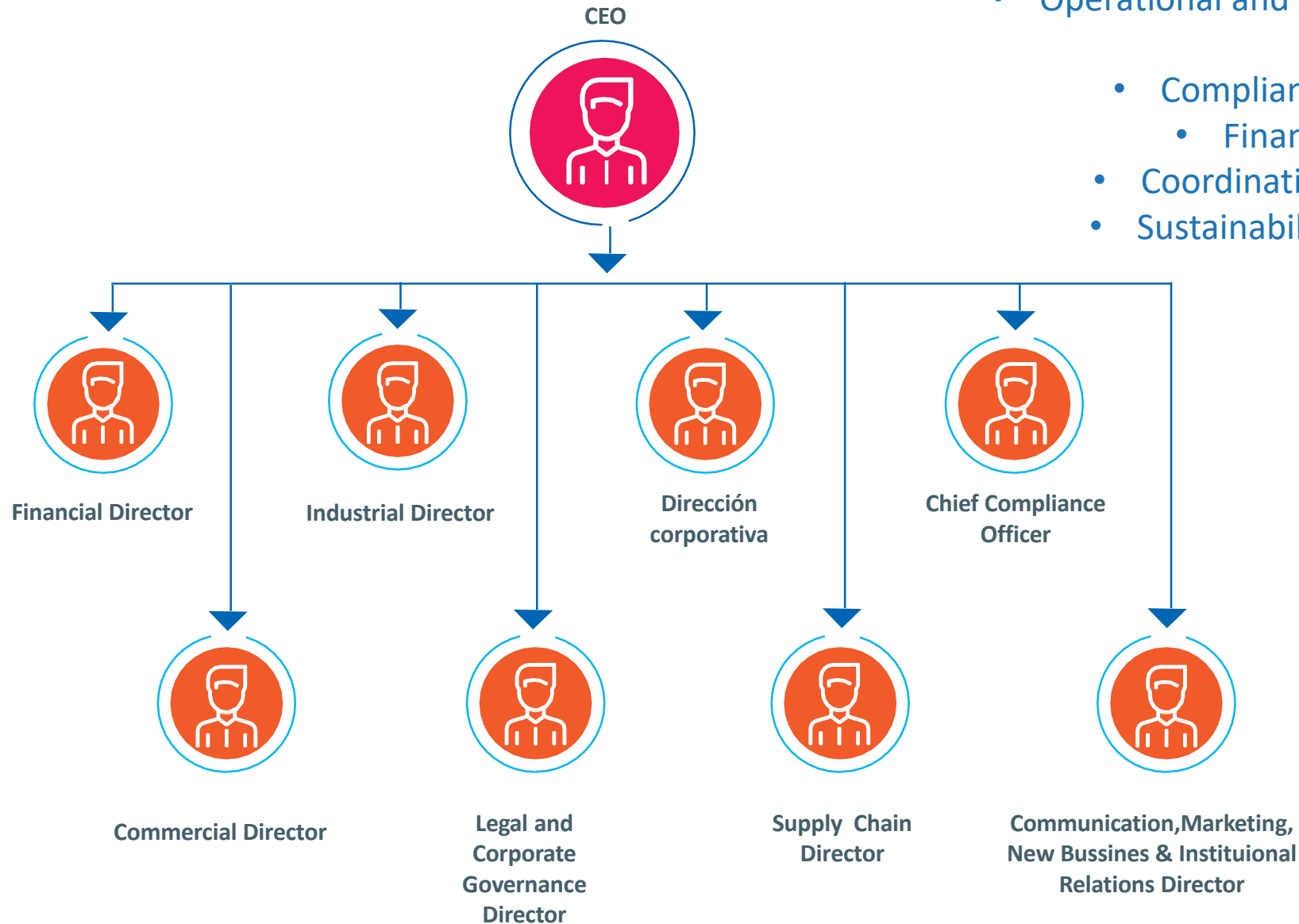
